

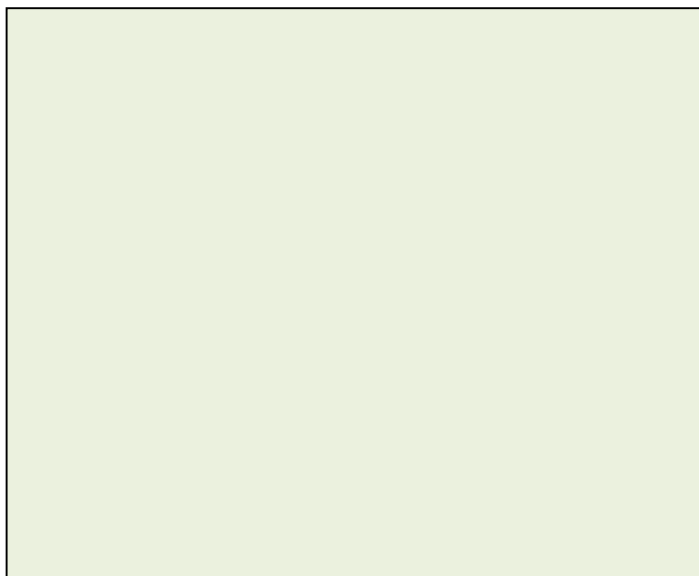

Surface: This project will be painted on the surface of your choice. The size of the design is approximately 10” x 8”. Base coat the entire surface with black or the color of your choice. The pattern will be provided and applied in class.

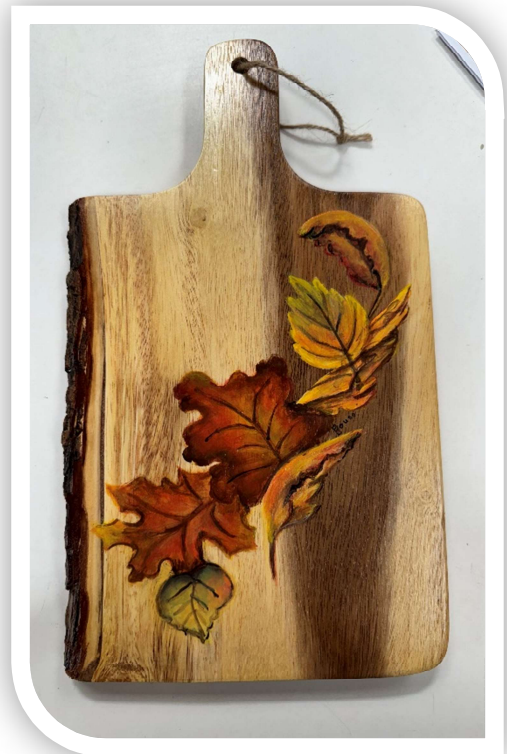
Paints: (DecoArt Americana)

- Soft Black
- Hauser Light Green
- Cadmium Red
- Deep Burgundy
- Burnt Umber
- Light Buttermilk
- Golden Straw
- Cadmium Yellow
- Bright Yellow
- Cadmium Orange
- Orange Twist
- Orange Flame
- Torrid Orange
- Lamp Black (or your chosen basecoat color)



Other Materials:

- White Graphite / Gray Graphite
- Stylus
- Palette Paper
- Pencil
- Brushes: a variety of your favorite acrylic brushes
- Usual Acrylic Painting Supplies:
 - Paper Towels
 - Water Basin
 - Tape

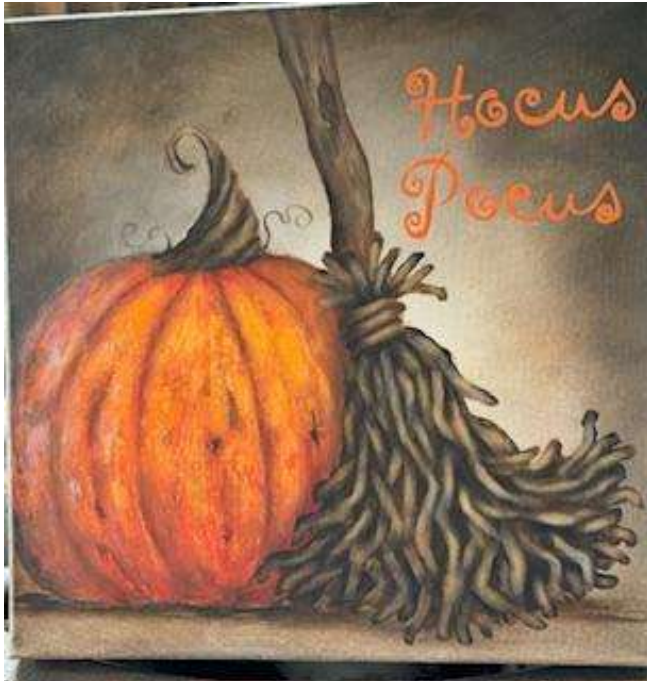
